TERMS AND CONDITIONS OF APS-RFBR AGREEMENT

AUTHORIZED USERS

APS (referred to as "Licensor") grants to the Russian Foundation for Basic Research ("RFBR") academic and government research member institutions ("Authorized Users") and its individual members online access to APS titles. This grant extends only to the Authorized Users and its individual members and may not be transferred or extended to others. For purposes of this Contract License, "the individual members of Authorized Users" means the employees, faculty, staff, and students officially affiliated with the Authorized Users, and persons with legal access to the Authorized Users' library collections and facilities on-site, using an IP address within the ranges identified in the APS Institutional Online Agreement -Appendix C. Authorized Users will exercise reasonable vigilance and shall be responsible for all access control and security measures necessary to ensure that the Authorized Users' IP addresses are not used to access Scitation by anyone other than Authorized Users. Authorized Users warrant and represent that common and reasonable methods will be used to inform the individual members of Authorized Users of general terms and conditions for the use of the licensed material that are consistent with this License Contract. Furthermore, Authorized Users will make every attempt to enforce the terms of this Contract License upon receiving information from Licensor or any other source that reasonably indicates that one or more individual members of Authorized Users is in violation of the terms of this License Contract.

IP ADDRESSES

Authorized Users and its individual members will be recognized and authorized by their Internet address. IP addresses and/or address ranges for the Authorized Users are indicated in Appendix C. PERMITTED USE

Authorized Users and its individual members may:

a. browse, search, retrieve, and view an Licensor Online Journal;

b. make one hard copy of the output of any search; such copies may not be sold and may not be distributed to anyone who is not a subscriber; and
